## ABOUT THE TOM MAYER AWARD

Thomas K. Mayer contributed to the well-being of children and families throughout his 35 year career, beginning with the Peace Corps in the 1960's and continuing through his retirement in 2004. Tom was a committed leader serving as the Region VII Director of the Office of Community Operations, Administration for Children and Families (ACF), U.S. Department of Health and Human Services.

Tom's living legacy includes a commitment to all in the area of advancing early care and education and specifically to Head Start programs in the ongoing effort to achieve and maintain high-quality service delivery. During his thirty-plus years with ACF, Mr. Mayer led the development of lasting federal, state, and local partnerships that continue to serve in the expansion of children and families receiving Head Start/Early Head Start services across Region VII.

Individuals nominated for this prestigious award should have demonstrated flexibility in their career and have documented experiences across the Head Start Program. Consideration will be given to individuals who made a long-term state or regional impact, as well as those who possess key characteristics of good leadership. Leadership examples include articulating a clear vision regarding a system for early care and education, the highest degree of integrity in their representation of Head Start, and demonstrated ability to build strong relationships and partnerships that serve to further the comprehensive nature of Head Start services to children and families. In addition, the nominee should have a demonstrated compassion and commitment to future Head Start program improvement and quality on a continuing basis.

# ANN LINEHAN SAFETY AWARD

The Region VII Head Start Association (R7HSA) established the Ann Linehan Safety Award in honor of Ms. Linehan on the announcement of her 2021 retirement as the Deputy Director of the Office of Head Start, ending her longstanding career with the Administration for Children and Families.

One only has to read Ms. Linehan's letter to grantees dated January 3, 2018, to understand the depth of her concern and passion for providing children a safe, nurturing, and loving environment. The letter attached to this application packet contains a difficult but important message shared with grantees regarding an alarming increase in reported number of child incidents while children were in the care of a Head Start/Early Head Start Program.

The *Ann Linehan Safety Award* builds on the R7HSA *Safe in Hand* Campaign launched in 2019 in response to Ms. Linehan's letter for the purpose of raising awareness and the importance of providing a safe indoor and outdoor classroom setting including transportation services, where provided, for every child handed off by a parent/caregiver to a Head Start/Early Head Start staff member is always the programs highest priority.

2022 marks the first year the Ann Linehan Safety Award was open for applications. The award will continue to be offered annually and awarded at an R7HSA annual event contingent upon receipt of qualifying recipient applications.

Award submissions will be reviewed by an impartial panel of experienced Head Start/Early Head Start professionals with former or current direct field program supervisory/management level experience.
